## **2 Scope and fees**

The yearly recurring fees for Bank XXX for using SignatureNet depend on the number of authorized signatories on the key date according to the following price ranges:

- The above prices are cumulative per year. They are in Swiss francs (CHF) and are exclusive of value added tax and/or other tax withholdings or government fees.
- The fee periods are based upon the calendar year. The fees are based upon the current number of employees/signatures and shall be charged in January of each year. They are payable within 30 days net. The fees shall be charged on a pro rata basis in the first year.
- The fee may be paid in Swiss Francs (CHF), Euros (EUR) or US Dollars (USD).\*
- The prices include SignatureNet-*online* for online data updates and to create PDFs
- The number of users and/or Administrators is unlimited.

## **3 Declaration**

We hereby declare that we are familiar with the stipulations of the General Terms and Conditions of Business of GSN Global Signature Net AG, Gubelstrasse 28, 8050 Zurich for Issuing Banks ("GTCs for Issuing Banks") and for User Banks ("GTCs for User Banks"), that we recognize them in their respectively valid version and will comply with them.

## **4 Applicable law and jurisdiction**

The contractual partners agree that, if there are differences of opinion, they will strive to achieve an amicable agreement, in all cases including the Swiss Bankers Association as intermediary, before calling on the courts. If a court decision cannot be avoided, exclusive jurisdiction is agreed to be with the court at Zurich. Swiss substantive law, with the exclusion of state treaties, will apply to this contract. This stipulation also applies to claims between the Issuing Bank and one or more User Banks when the claims have a material connection with the use of SignatureNet by the User Bank and the Issuing Bank(s).

\* The official exchange rate on the date of invoice shall apply for payments made in EUR or USD.
